

This RTIS Terms of Services is a legal agreement among you on the one hand, and RTIS monitors on the other hand. The following Terms of Service govern your use of the RTIS website and all of the products and services offered by RTIS.

This includes analyzing the data we have about our users and understanding how people use our service.

If you download or use our software, you give us permission to download and install updates to the software where available.

We work constantly to improve our services and develop new features to make our service better for you. As a result, we may need to update these Terms from time to time to accurately reflect our services and practices. We will only make

changes if the provisions are no longer appropriate or if they are incomplete, and only if the changes are reasonable and take due account of your interests. We will notify you (for example, by email or through our Products) before we make changes to these Terms and give you an opportunity to review them before they go into effect, unless changes are required by law. Once any updated Terms are in effect, you will be bound by them if you continue to use our Products.

If we determine that you have clearly, seriously or repeatedly breached our Terms or Policies, we may suspend or permanently disable access to your account. SECTION 1 The Services:

(a) **Platform: Resource Tracking Information System (RTIS)** is a website or app which helps you to keep track of your factory's footprint and resources consumption progress and the harmful gasses or chemicals emitted by them. It creates an easy path for you to get connected to buyers and consultants. It also assists you in keeping record of your maintenance schedule(s) and implementation plan(s).

(b) **Users:** There are three types of users for this app. They are:

1. **Factory-** All types of factories (manufacturing, garments, etc.) can use this app for tracking their factory's information. They can also connect to their desired brands and consultants.
2. **Brand-** All the brand(s) can use this app to get connected to various factories and consultants.
3. **Consultant-** Consultant(s) can get connected to factories and brands through this app and provide beneficial recommendations.
4. **Users-** Factory employee(s) can use this app as a user once approved by admin.

(c) **Tools and Modules:**

1. **Tools-** The tools that we have provided to you are:
 - (i) **Dashboard:** Dashboard is the interface of the app. As soon as you login the first thing that appears is the dashboard, which exhibits the factory's **graph reports and pie charts, factory information, maintenance schedule(s) and implementation plan(s).**
 - (ii) **Footprint:** Footprint displays the module(s) or folder(s) of your factory. The modules include the monthly data of your factory.

- (iii) Key Performance Indicator (KPI):** KPI shows your factory's monthly performance for each module.
- (iv) KPI Compare:** KPI Compare compares your factory's yearly performance from each module.
- (v) Data Entry:** Data entry option is where you input your factory's data of all the years upto the running year and month.
- (vi) Data Verification:** Data verification is where the brands and consultants verified the factory's data. This tool makes sure that no false data has been input.
- (vii) Factory Connection:** Factory Connection is where you get brand and consultant requests. After accepting the request, you can see the connected brands and consultants.
- (viii) Documentation:** Documentation is where you get a user manual pdf and tutorial of the RTIS app. Through this you will get all the enlightenment you need to operate this app smoothly.
- (ix) Profile:** Profile is where the admin puts his/her information (name, title and phone) and you can change the password, too.

2. Modules- Modules are basically factory departments. Like- GHG, Energy, Power, Thermal, etc.

Section 2 Access and Use of the service:

- 1. Registration:** Accessing and using the app requires registration and creation of an account on the Platform. You can register as a factory or brand. You can also upload any document that proves your identity.
- 2. Restrictions:** You may not use the Account, username, or password of someone else at any time. You agree to notify RTIS immediately of any unauthorized use of your account, user name, or password. You may be held liable for any losses incurred by RTIS due to someone else's use of your Account or password.
